1. **EXECUTIVE SUMMARY**

Ontarians with disabilities experience many kinds of restrictions including barriers to customer service, information and communication, physical environment, and employment.

Stackpole International is committed to taking the necessary steps to increase its accessibility for persons with disabilities. Stackpole will continue to identify, remove and prevent barriers for persons with disabilities. Stackpole is committed to being fully accessible to persons with disabilities, in accordance with the AODA, by 2025.

2. **SCOPE**

- Distributed offers of employment that advise new hires of our accessibility policy (2015)
- Created an Accommodation Plan Procedure and Plan document for existing and new employees who would require accommodation in the workplace (2015)
